### A: Terminology

- 1. "Author-Entrant" means "Author of an Entered Manuscript".
- 2. (i) "Awardee" means an Author-Entrant who is awarded The Proverse Prize and/or an Author-Entrant who is one of two Author-Entrants who jointly share The Proverse Prize.
- (ii) An Awardee may be an Author whose manuscript was entered by Proverse Hong Kong in the circumstances described in paragraph "O" below.
- 3. (i) "Supplementary Prize Awardee" means an Author-Entrant who is not awarded The Proverse Prize or a half share of The Proverse Prize but is awarded publication as a Supplementary Prize.
- (ii) A Supplementary Prize Awardee may be an Author whose manuscript was entered by Proverse Hong Kong in the circumstances described in paragraph "O" below.
- 4. "Entered Manuscript" means "a literary work in the English Language in typed or word-processed form in both a hard copy and a soft copy entered for The Proverse Prize".
- a) If any illustrations including but not limited to photographs, diagrams, drawings, tables, etc. are included in the Entered Manuscript or sent separately with or without a note indicating where in the Entered Manuscript each of these belongs, these are included within the term "Entered Manuscript".
- 5. "Entering for The Proverse Prize" means submitting a) an Entered Manuscript and b) a completed, signed, witnessed and dated Entry Form/ Entry Documents and c) Entry Fee.
- 6. "Entry" means the Entered Manuscript and completed, signed, witnessed and dated Entry Form and signed, witnessed and dated Entry Documents and Entry Fee taken together.
- 7. "Entry Documents" means both a completed, signed, witnessed and dated Entry Form (Section D) and signed, witnessed and dated Terms and Conditions (Section E).
- 8. "Non-entered Manuscript" means a Manuscript submitted by Proverse Hong Kong for the consideration of the Judges in the circumstances described in paragraph "O" below.

- 11. "The Publishers" refers to "Proverse Hong Kong". The expression, "The Publishers" shall include any publishing imprint subsidiary to or associated with The Publishers, and The Publishers' administrators and assigns or successors in business as the case may be.

If in any year the Judges recommend only one Entered Manuscript as deserving of The Proverse Prize or a Supplementary Prize (if any), The Publishers have the right to submit any Non-entered Manuscript of an eligible genre and eligible length in its possession by an eligible author to be considered by the Judges for the award of The Proverse Prize or a Supplementary Prize (if any) on an equal footing with eligible Entered Manuscripts and may request such an eligible author of an eligible manuscript to complete the Entry Documents, adapted as may be necessary to suit the particular case and pay the entry fee.
- 4. Should the Judges agree that such a Non-entered Manuscript is equally deserving of The Proverse Prize and recommend it for The Proverse Prize which includes publication by The Publishers or if the Judges recommend such a Non-entered Manuscript for the award of publication by The Publishers as a Supplementary Prize (if any), the publication agreement that applies shall be the same as for Entered Manuscripts unless a publication agreement is already in place between the author of such a Non-entered Manuscript and The Publishers, and in this case the pre-existing agreement shall prevail.

#### P: Cash award to be shared equally between Author-Entrant and his/her Translator:

Any Entered Manuscript which is not 1) an unpublished publishable work of non-fiction, fiction or poetry, the original work of the Author-Entrant, written and submitted in the English language OR 2) an unpublished publishable translation into English of an original work of the Author-Entrant which is a work of nonfiction, fiction or poetry written in a language other than English which may or may not have been previously published in a language other than English OR 3) an original unpublished publishable new translation into English by the Author-Entrant of an out of copyright work (e.g. a classical text) of non-fiction, fiction or poetry by another Author, which has previously been translated by one or more other translators and published in English is ineligible. The Author-Entrant must own the copyright in the Entered Manuscript. If the copyright in the Entered Manuscript does not belong to the Author-Entrant, the Entered Manuscript is ineligible. Self-published works are eligible provided the Author-Entrant has retained the copyright in the Entered Manuscript. Author-Entrants of such self-published works should submit evidence of their copyright at the time they submit their Entered Manuscript and should explain clearly the nature and extent of

- such prior self-publishing of the Entered Manuscript. It is regretted that no correspondence can be entered into on this topic. Mixed-genre submissions (e.g. poetry and essays) by a single Author-Entrant would not be ruled out.
- 2. School textbooks and plays should not be entered and are ineligible.
- 3. A translation into English of an Author-Entrant's own manuscript (whether the translation is by the Author-Entrant him or herself or by another person) should be entered by the Author-Entrant.

- 6. <u>Previous Winners of Other Prizes</u>: An Entered Manuscript which has previously won any other prize which includes publication may be ineligible depending on the conditions for such publication.

- 3. A footer should contain the page number and the title of the Entered Manuscript (<u>BUT NOT</u> the Author-Entrant's name or the Translator's name (if any)).
- 4. Guidelines for page layout. The page should have the following margins: Top, 0.8", Bottom, 0.6", Right Hand and Left Hand margins, 0.9". Tabs should be set at 0.2". The first line of a chapter should not have a tab. The first line after a line space should not have a tab. The first line after an asterisk or other indication of a switch in the narrative and/ or narrative time or similar should not have a tab. Headers should be 0.4" from the top of the page. Footers should be 0.3" from the bottom of the page. If you are not able to follow these guidelines, do not worry; your Entered Manuscript will not be disqualified because of this.
- 5. Please do not add any formatting.
- 6. For the table of contents, please do this manually and please do not set any bookmarks.
- 7. Please do not set any grid.
- 8. Use double quotation marks for direct speech and single quotation marks for any quotes within quotes.
- 9. In any quotation from another's words, please use inverted commas and not italics (but please preserve any italics that may be present in the original from which you are quoting).
- 10. If, in addition to more common usages, italics are used to indicate a shift in the narrative voice or in narrative time, please supply a note stating the convention(s) you are using.
- 11. All Entered Manuscripts should include a manual Table of Contents (including page numbers), particularly Poetry Collections, Short Story Collections, Essays. But please see point 6 above.
- 12. Since the Judges will consider whether or not to recommend to The Publishers that they publish the best Entered Manuscript / best two Entered Manuscripts / other excellent Entered Manuscripts, excellent presentation (including attention to basics such as punctuation, spelling and grammar) will be a factor that the Judges will take into consideration when deciding which Entered Manuscripts (if any) to recommend for publication. # **EEE: Copyright in Illustrations**

- 1. If an Awardee and/ or Supplementary Prize Awardee does not own the copyright of any illustration including but not limited to photographs, diagrams, drawings, tables, etc., which he/she provides to The Proverse Prize Administrators and/or The Publishers as part of the Entered Manuscript and/or as part of the Revised Entered Manuscript and/or as part of the Modified Entered Manuscript and/or as part of the Modified Revised Entered Manuscript and/or as part of the "Manuscript after it has been prepared for publication" for inclusion in the Published Work, the Author-Entrant / Awardee / Supplementary Prize Awardee (if any) will inform The Publishers of this when he/she sends such illustration to the Proverse Prize Administrators and/or The Publishers.
- 2. The Author-Entrant / Awardee and/or Supplementary Prize Awardee will obtain from any such copyright holders written and signed permission on official letterhead (if any) to reproduce the illustrations whether in the Entered Manuscript or in the Published Work, and provide to The Publishers non-returnable originals of these permissions in hard copy form and also in soft copy form. The Author-Entrant will meet the cost of permission fees for all illustrations provided by herself/himself.
- 3. The Author-Entrant will provide copies of correspondence and receipts as evidence of such settlement.
- 4. The Author-Entrant will provide The Publishers clear documentation of any acknowledgement or permissions wording required by the owner of any illustrations (including but not limited to photographs, diagrams, drawings, tables, etc.).
- 5. Should The Publishers undertake to obtain any illustration and settle the relevant fees themselves, they will advise the Author-Entrant in advance of the cost of the relevant fees for the Author-Entrant's agreement and the Author-Entrant will reimburse The Publishers' out-of-pocket costs as soon as requested to do so by The Publishers.
- 6. If the Author-Entrant / Awardee and/or Supplementary Prize Awardee does own the copyright of any illustration including but not limited to photographs, diagrams, drawings, tables, etc., which he/she provides to The Proverse Prize Administrators and/or The Publishers as part of the Entered Manuscript or for inclusion in the Published Work, the provision of such illustrations automatically conveys permission for them to be used in the Published Work and no fees for their use in the Published Work are to be paid by The Publishers to the Awardee and/or Supplementary Prize Awardee. The Author-Entrant will supply a permissions and/or copyright statement for each and every such illustration and if The Publishers use any such illustrations in the Published Work The Publishers will include these statements as appropriate.

# FFF: Permissions and permissions fees for Textual Quotations from copyright works

- 1. The cost of permission fees for textual quotations from copyright works will be met by the Author-Entrant / Awardee / Supplementary Prize Awardee, who will obtain written and signed permission / licences on official letterhead (if any) and supply non-returnable originals both in hard copy and soft copy of these permissions / licenses to The Publishers.
- 2. Should The Publishers undertake to obtain any permissions / licenses for textual quotations and settle the relevant fees themselves, they will advise the Awardee / Supplementary Prize Awardee in advance of the cost of the relevant fees for

- 6. If the Awardee / Supplementary Prize Awardee prefers and if the Publishers agree, he or she may scan any such pages and send them as an email attachment to the Publishers to proverse@netvigator.com.
- 7. # KKK: Descriptive texts of the Entered Manuscript as a Published Work:

When requested, the Awardee / Supplementary Prize Awardee shall provide The Publishers in separate soft files clearly labeled two descriptive texts of the "Manuscript after it has been prepared for publication" in 100 and 300 words respectively which The Publishers may use as a basis for texts to be used for the promotion of the Published Work and / or in the Published Work itself.

# **LLL: Key Words**

The Awardee / Supplementary Prize Awardee shall <u>prepare a list of</u> ten key words in order of important / relevance which in the judgement of The Publishers shall assist The Publishers in the dissemination of information on the Published Work through electronic databases electronic networks and other electronic information technology devices and provide these on request from The Publishers.

# **MMM: Signed Copies**

The Awardee / Supplementary Prize Awardee agrees to sign at least 10 (ten) copies of the Published Work, if and when provided by the Publishers for this purpose to be used by the Publishers for special sales, events, prizes, gifts, or any other purpose.

# NNN: Awardee / Supplementary Prize Awardee's Prepaid Pre-production/publication Copies

### ZZZ: Accounts

Minor edits of the Published Work may or may not be incorporated as The Publishes may decide.
- 2. Royalties on audiobooks sold by The Publishers (e.g. from The Publishers' own website, if available) will be as follows: 20% of The Publishers' net receipts after payment for 50 (fifty) copies has been received by The Publishers.
- 3. Royalties on audiobooks sold by other agencies will be as follows: 20% of The Publishers' net receipts after such sales have been notified to the Publishers by such other agency / agencies and after payment for 50 (fifty) copies of such ebooks notified sold has been received by The Publishers.

# **DDDD:** Royalties from serial rights and other subsidiary rights

In connection with serial rights and all other subsidiary rights in connection with which royalty percentages are not mentioned elsewhere in this Agreement excluding any received through any society of which The Publishers are a member, The Publishers will pay royalties of 50% on their net receipts. # **EEEE: Publication of Translation(s) by The Publishers**

**HHHH: Windfall benefits** The Awardee / Supplementary Prize Awardee and The Publishers mutually agree that any and all windfall benefits shall be shared 50%/50% (fifty percent / fifty percent).

- 1. Windfall benefits if any will not be included in the royalty accounts, but shall be shared out and remitted to the other party as soon as possible and in any case within six months of receipt by either party.
